# COVID-19 Relief Measures

## Government of Tamil Nadu



---

### Ration Card Holders

#### I **Food Grains**

##### Q. What is the benefit?

- Card-holding families will get the essential commodities - **rice, dal, cooking oil and sugar - free of cost** for the month of April.
- Those households who failed to get rations in March can collect it in April along with April ration.

##### Q. Who is going to benefit?

Every household with a ration card will be eligible for this.

#### I **Cash Transfer**

##### Q. What is the benefit?

- A one-time payment of ₹1000.

##### Q. Who is going to benefit?

Every household with a rice ration card will be eligible for this cash payment.

### General Public

#### I **Cooked Food**

##### Q. What is the benefit?

- Cooked food will be served at Amma canteen across the state at **subsidised prices**.

##### Q. Who will benefit?

Open for everyone but with a special focus on the poor and destitute.



---

### MGNREGA Workers

#### I **Cash Transfer**

##### Q. What is the benefit?

- Amount equivalent to **wages for two days**.

##### Q. Who is going to benefit?

Active workers or job-card holders under MGNREGA.



---

## Construction Workers

### **I Cash transfer and food rations**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000.
- **15 kgs of rice, 1 kg of dal and 1 litre of cooking oil** per household to be given free of cost.

#### **Q. Who benefits?**

All registered workers under Building and Other Construction Worker Welfare Board.

## Autorickshaw Drivers

### **I Cash transfer and food rations**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000.
- **15 kgs of rice, 1 kg of dal and 1 litre of cooking oil** per household to be given free of cost.

#### **Q. Who benefits?**

All registered auto rickshaw drivers registered under Drivers' Welfare Association.

## Platform vendors

### **I Cash transfer**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000.

#### **Q. Who will benefit?**

Platform vendors who are registered with the government.



---

## Migrant Workers

### **I Cooked food, rations**

#### **Q. What is the benefit?**

- **15 kgs of rice, 1 kg of dal and 1 litre of cooking oil** to be distributed per family free of cost.
- Cooked food will be served through **Amma canteens**.

#### **Q. Who will benefit?**

Unorganized workers from other states and regions who are staying back. These workers will be identified by the respective government bodies.

## **I Deferred payment of rent**

### **Q. What is the benefit?**

- Rent collection from tenants will be **suspended for two months**.

### **Q. Who will benefit?**

Unorganized workers from other states and regions who are staying back.



---

## **Transgender persons**

### **I Cash Transfer**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000.

#### **Q. Who is going to benefit?**

All transgender persons will be eligible for this payment.

### **I Ration Kit**

#### **Q. What is the benefit?**

A special kit of **12 kg rice, 1 kg dal, 1 litre cooking oil** per head.

#### **Q. Who is going to benefit?**

All members of the transgender community who do not have ration cards.

## **Elderly**

### **I Food delivery**

#### **Q. What is the benefit?**

- **Cooked food** to be delivered directly to the household.

#### **Q. Who benefits?**

Elderly dependent upon anganwadis.
