# COVID-19 Relief Measures

## Government of Uttar Pradesh



---

### Ration Card Holders

#### ■ **Food Benefit**

##### Q. What is the benefit?

- One month stock of **food grains (20kg wheat, 15kg rice)** to be provided **free of cost**

##### Q. Who benefits?

Every Antyodaya beneficiary will be eligible for in-kind rations.



---

### Pensioners

#### ■ **Advance Payment of Pensions**

##### Q. What is the benefit?

- Advance payment of pension amount **for two months** – April and May , 2020

##### Q. Who benefits?

Beneficiaries of all social security pensions given out by Government of Uttar Pradesh.

### Students and Unorganised Workers

#### ■ **Deferred payment of rent**

##### Q. What is the benefit?

- Payment of rent for tenancy will be **deferred by one month**.

##### Q. Who benefits?

Unorganized workers and students who are living in Lucknow as tenants.

## Construction Workers

### **I Cash transfer and ration benefit**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000, and foodgrain stock for one month free of cost

#### **Q. Who will benefit?**

All registered workers under Building and Other Construction Worker Welfare Board

## Rickshaw Pullers, Street Vendors and Small Traders

### **I Cash transfer and in-kind rations**

#### **Q. What is the benefit?**

- A one-time payment of ₹1000.
- Provision of ration card, if the beneficiary does not have one.

#### **Q. Who benefits?**

All registered autorickshaw drivers registered under Drivers' Welfare Association.

## MGNREGA Workers

### **I Food grain Benefit**

#### **Q. What is the benefit?**

- **One month** stock of food grains (20kg wheat, 15kg rice) to be provided **free of cost**.

#### **Q. Who will benefit?**

All job-card holders under MGNREG scheme.



---

## Workers

### **I No deduction in salary or wage**

#### **Q. What is the benefit?**

- Workers will get **full salary or wages** during the lockdown period.

#### **Q. Who benefits?**

All permanent, contractual and casual workers in public or private employment.

## **I Cash Transfer**

### **Q. What is the benefit?**

- A one-time payment of ₹ 1000.

### **Q. Who benefits?**

Those workers in rural or urban areas, whose livelihood has been affected but have not benefitted from any of the state schemes. Gram panchayat or Urban Local Body to identify such persons.



## **Migrant Workers**

### **I Relief Camp**

#### **Q. What is the benefit?**

- **Shelter, food and other essentials** will be provided at relief camps which will play the role of quarantine centers

#### **Q. Who benefits?**

Unorganized workers who have returned from other states.



## **Farmers**

### **I Public procurement of Rabi crops**

#### **Q. What is the benefit?**

- Procurement of **mustard at ₹4425 per quintal.**
- Procurement of **gram at ₹4875 per quintal.**
- Procurement of **lentil (masoor) at ₹4800 per quintal.**

#### **Q. Who benefits?**

Farmers.
