# COVID-19 Relief Measures

## Government of West Bengal



---

### Ration Card Holders

#### I **Foodgrain benefit**

##### Q. What is the benefit?

- Rice and wheat to be provided **free of cost till September** (maximum 5kg per month).

##### Q. Who benefits?

Households having any of the following ration cards: Antyodaya Anna Yojana(AAY) , State Priority Household (SPHH), Priority Household Card (PHH) and Rajya Khadya Suraksha Yojana-I (RKSJ-1) card .

#### I **Foodgrain benefit (RKSJ-II)**

##### Q. What is the benefit?

- **Rice at ₹ 13** per kg and **wheat at ₹ 9** per kg will be provided.

##### Q. Who benefits?

Families having Rajya Khadya Suraksha Yojana-II (RKSJ-II) cards .

### Migrant Workers

#### I **Cooked food, shelter and other essentials**

##### Q. What is the benefit?

- **Temporary shelters** will be provided along with food and other essential items.

##### Q. Who benefits?

Unorganized workers from other states and regions who are staying back.

### Workers

#### I **Food grains**

##### Q. What is the benefit?

- Workers will get **full salary or wages** during the lockdown period.

##### Q. Who benefits?

All permanent, contractual and casual workers in all commercial establishments and shops.

## Persons involved in COVID-19 Related Duties

### I **Insurance policy**

#### Q. What is the benefit?

- **Free treatment** for Covid-19 patients in hospitals under government control.
- Additional financial assistance of **₹1 Lakh**.
- **₹10 Lakh** will be given to the family of those who died due to Covid-19
- Family members of these persons will also be considered for free treatment.

#### Q. Who benefits?

- All ICDS workers and helpers .
- Persons involved biomedical waste management.
- Transport personnel
- Cooks, washermen, ayas working in government and private hospitals.
- All healthcare related personnel - doctors, nurses, paramedics
- State police personnel, central police forces, defence forces, staff in airports, ports, and railways.
- All permanent, temporary and contractual employees in Health and Family Welfare Department
- All employees working in public transport departments in the state.

## Mental Health

### I **Counselling**

#### Q. What is the benefit?

- The State Government is providing counselling to those living in institutional quarantine.
- This is done to protect their mental well-being and to prevent them from feeling isolated.

#### Q. Who benefits?

All marked as quarantined as a result of CoVID-19 and residing in institutional quarantine.

## Daily Wage Workers

### I **West Bengal Prochesta Scheme**

#### Q. What is the benefit?

- Each worker will get ₹1000
- The registration to be available for this scheme will begin from the 1st of April, 2020

#### Q. Who benefits?

- Daily Wage workers registered with the State government.
- These workers must be residents of the State.

## Children

### I **Provision of Mid-Day Meal Schemes**

#### Q. What is the benefit?

- Anganwadi centres in the state to **deliver mid-day meals** to children at their homes

#### Q. Who benefits?

All children enrolled in Anganwadis.
